Stroke identification: (The following information was submitted by **Bill Fleisher**) Medical researchers state that if you can get a stroke victim medical assistance within 3 hours, the effects of the stroke can be totally reversed. You can recognize a stroke by asking 3 simple questions - 1 - Ask the individual to **smile**, 2 - Ask the person to **raise both arms - 3-** Ask the person to **speak a simple sentence** (coherently) ie: It is sunny out today. . . If he or she has any trouble with any of these tasks call 9-1-1 immediately and describe the symptoms to the dispatcher. Use of this test could result in prompt diagnosis and treatment of the stroke and prevent brain damage.


