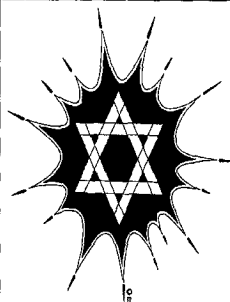

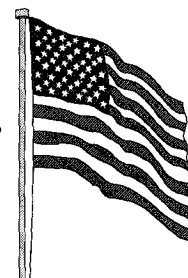

Forwarded from the 'net by Howard Rabinovitch -
School 1960 vs. School 2008 -

Scenario - Johnny & Mark get into a fistfight after school.

1960 - Crowd gathers. Mark wins. Johnny & Mark shake hands and end up best friends.

American companies that financially support Israel:

1. **STARBUCKS** - The Chairman & CEO is Howard Schultz, an active Zionist. At a time when other businesses were desperately pulling out of Israel, Starbucks decided to help Israel's floundering economy and invested in Israel. 3. **THE HOME DEPOT** - Its founder and Co-chairman of the Board is an active Zionist. He created the board of directors of Emet, the pro-Israel media 'War Room', whose function is to ensure that all media in the U.S. stays biased in favor of Israel.
4. **DISNEY** - Walt Disney's Millennium exhibition at the Epcot Centre in Florida depicts Jerusalem as the capitol of Israel, contributing 1.8 million dollars towards its 8 million dollar cost, also worked with Disney to develop its content.
5. **AOL-TIME WARNER** - AOL allocates 30% of its investment portfolio in Israel. Its buy up of Israeli company Mirabilis for \$287 million in 1998 forms part of AOL's investment in Israel.
6. **COCA COLA** - from 1966 onward. Coca Cola has been a staunch supporter of Israel.
7. **ESTEE LAUDER** -Chairman Ronald Lauder, is an ardent Zionist. He is currently president of the Jewish National Fund (JNF).
8. **SARAH LEE** - (the clothing giant) - Hanes, Playtex, Leggs, Champion - Owns 30% of Israel's leading textile company, Delta Galil. As the world's largest clothing manufacturer, thus opened the door for cloths originating in Israel being sold around the world under one of the many famous Sarah Lee brands.
9. **FOX TELEVISION - FOX ENTERTAINMENT** - The News Corporation Limite is one of the world's largest news media companies. Murdock's News Corporation invests heavily in Israel. News Corporation's digital technology company, based in Jerusalem, called NDS, has grown from 20 to 600 employees in the past decade.
10. **NESTLE** - The Swiss company owns 50.1 % of Israel Food maker Osem Investments. It has been recognized by Israel as one of the companies who have done the most to strengthen the Israeli economy.
11. **OVERSEAS ADVENTURE TRAVEL** - As it's president is a Zionist, it donated one million dollars to Israel to help fund schools, food aid, etc.
12. **IBM** - Invests heavily in Israel. Established operations in 1949 and was the first large American company with a wholly owned subsidiary in Israel, introduced computers to Israel and employs 1,700 people.
13. **KIMBERLY-CLARK** - Huggies, Kotex, Kleenex - owns 49.9 % interest in Israeli company Hogla, through America-Israel Paper Mills. Recognized by Israel as one of the companies that have done the most to strengthen the Israeli economy.
14. **NOKIA** - Nokia Ventures Organization, Nokia Research Centers. They have invested heavily in Israel and are on the lookout for Israeli start-ups with which they can cooperate.
15. **TIMBERLAND** - Clothing, shoes, boots, jackets, etc. It's President and CEO Jeffrey Swartz, is a Zionist.
16. **CATERPILLAR** - Company, based in Illinois, manufactures large construction equipment. Supplies Israel with all of its current fleet of D9 and D10 bulldozers, some of the largest armored bulldozers in the world.
17. **RIVER ISLAND (Clothing chain), ISROTEL, IBROTEL HOTELS, (Spain & Portugal), BRITANNIA PACIFIC PROPERTIES,** - A diversified international investment company headquartered in London, England. Said to be one of the largest real estate owners in the Sacramento Metropolitan area. Their Lewis Trust Group is one of the companies developing hotels in the Aqaba Region. Davis Lewis, Chairman of the company, is a prominent supporter of Israel.
18. **DESERT EAGLE** - firearms. They are the only firearms that Israel does not buy from the U.S.or other countries. However, many of the parts are manufactured in other countries and they are merely assembled in Israel. Regardless, Israel prides them as their own and it is strictly an Israeli company.

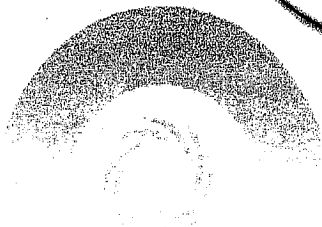

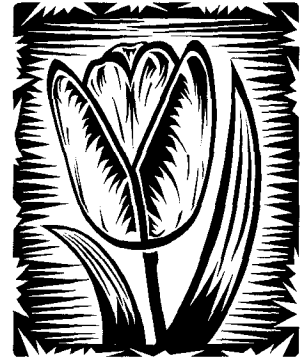
