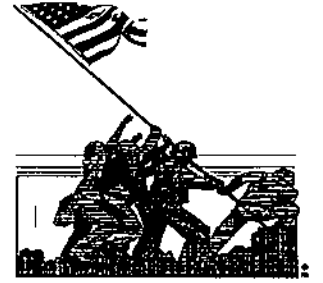

Arthur Gravitz reports:

As a result of a letter I sent to **Amy Gutmann**, President of the University of Pennsylvania, asking her to apologize to all State of Israel supporters and alumni like me for allowing the BDS conference at the University, I received the following from **John Zeller**, Vice President, University of Pennsylvania:

Dear Mr. Gravitz:

Thank you for sharing your concerns with Dr. Gutmann about the conference hosted by the Penn BDS student group at the beginning of February. Please allow me to respond on her behalf. The University has repeatedly and forcefully stated that we adamantly oppose sanctions or boycotts against Israel. Indeed, we fundamentally disagree with the position that these few students are taking. At the same time, we recognize and respect their right to open expression.

To briefly address your thoughts about open expression and discriminatory groups, I can assure you that the University follows strict policies regarding discrimination and equal opportunity. The Student Activities Council (SAC) unanimously approved the group's recognition, based upon stringent guidelines that all student groups must adhere to. One of the reasons Penn BDS was permitted to be an active group is because - under SAC guidelines, they are non-discriminatory in their membership, unlike KKK organizations you mention. Moreover, Penn BDS does have Israeli students among its members, which speaks to its adherence to regulations in being an inclusive organization.

The February conferences were not, in any capacity, University sponsored or promoted. The student group must follow University and SAC guidelines when they want to host meetings and or events on campus, just like other student groups who wish to do so.

Free, open, and meaningful discussions will continue to occur and create opportunities for even more dialogues at the University. This exchange of ideas and philosophies in an orderly fashion, despite how much we disagree with the content, is one of the key elements of a great university. I know that you will agree that freedom of speech is what enables our institution to thrive and grow.

“WHO WAS HAYM SOLOMON?” (A fascinating history of the \$1 bill.)

On the rear of the One Dollar Bill, you will see two circles. Together, they comprise the Great Seal of the United States. The First Continental Congress requested that Benjamin Franklin and a group of men come up with a Seal. It took them four years to accomplish this task and another two years to get it approved.

If you look at the left-hand circle, you will see a Pyramid. Notice the face is lighted and the western side is dark. This country was just beginning. We had not begun to explore the west or decided what we could do for Western Civilization. The Pyramid is uncapped, again signifying that we were not even close to being finished. Inside the Capstone you have the all-seeing eye, an ancient symbol for divinity. It was Franklin's belief that on man couldn't do it alone, but a group of men, with the help of God, could do anything. **'IN GOD WE TRUST'** is on this currency.

The Latin above the pyramid, **ANNUIT COEPTIS**, means *'a new order has begun'*.

At the base of the pyramid is the Roman Numeral for 1776. (MDCCLXXVI)

If you look at the right-hand circle, and check it carefully, you will learn that it is on every National Cemetery in the United States.

It is also on the Parade of Flags Walkway at the Bushnell, Florida National Cemetery, and is the centerpiece of most heroes' monuments.

Slightly modified, it is the Seal of the President of The United States. and it is always visible whenever he speaks, yet very few people know what the symbols mean.

The Bald Eagle was selected as a symbol for victory for two reasons: First, he is not afraid of a storm; he is strong, and he is smart enough to soar above it. Secondly, he wears no material crown. We had just broken from the King of England. Also, notice the shield is unsupported. This country can now stand on its own.

At the top of that shield there is a white bar signifying congress, a unifying factor. We are coming together as one nation.

In the Eagle's beak you will read, **'E PLURIBUS UNUM'** meaning 'from many - one.'

Above the Eagle, we have the thirteen stars, representing the thirteen original colonies, and any clouds of misunderstanding rolling away. Again, we are coming together as one.

Notice what the Eagle holds in his talons. He holds an olive branch and arrows. This country wants peace, but we will never be afraid to fight to preserve peace. The Eagle always wants to face the olive branch, but in time of war, his gaze turns toward the arrows.

An (untrue) old fashioned belief says that the number 13 is an unlucky number. This is almost a worldwide belief. You will almost never see a room numbered 13, or any hotels or motels with a 13th floor.

But think about this:

America, which relies on God (not a number) to direct and lead, boldly chose:

13 original colonies - 13 signers of the Declaration of Independence - 13 stripes on our flag - 13 steps on the Pyramid - 13 letters in 'Annuit Coeptis' - 13 letters in 'E Pluribus Unum' - 13 stars above the Eagle - 13 bars on that shield - 13 leaves on the olive branch - 13 fruits and if you look closely, 13 arrows.

And finally, notice the arrangement of the 13 stars in the right-hand circle. You will see that they are arranged as a Star of David.

This was ordered by George Washington who, when he asked Haym Solomon, a wealthy Philadelphia Jew, what he would like as a personal reward for his services to the Continental Army. Solomon said he wanted nothing for himself, but he would like something for his people. The Star of David was the result.

Few people know it was Haym Solomon who saved the army through his financial contributions..... then died a pauper. Haym Solomon gave \$25 million to save the Continental Army, money that was sorely needed to help realize America's - *our* - freedom and independence from England.

Therein lies America's Judeo - Christian beginning.

Most American children do not know any of this. They are not taught because their history teachers do not know of any of this, as they were not taught!

Let's do whatever we can to save America, while never, ever forgetting:
