

Some tips from:

It's when a check that you have written falls into the wrong hands and the thieves then soak it in bleach to remove the ink and re-write the check to themselves. **Uni-ball** makes a pen #207, that has a gel ink that soaks into the fibers of the paper and keeps the check from being 'washed'. They can be purchased at any office supply store and are not expensive.


