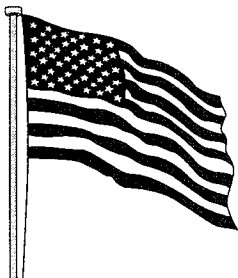

As a twenty-four year veteran of the volunteer fire service in Pennsylvania and past Fire Chief, **Chief Wurster** has made significant contributions to the education and and training of public safety professionals globally.

He has served as **Chief Safety Officer** of the Abington Township Fire Department.

While serving as **Director of Curriculum and Certification** for the **Bucks County Public Training Center**, he facilitated a high rate of program expansion for professionally recognized certification in fire and emergency services disciplines.

He also served as the **Director of Public Safety for Abington Memorial Hospital**, a regionally accredited trauma center.

A recognized leader in public safety education, **Chief Wurster** has delivered numerous presentations in Turkey, South Korea, Canada and throughout the United States. Shomrim speaker 30 years ago -

On October 9, 1980, **Shomrim's** guest speaker was Philadelphia District Attorney **Ed Rendell**. He spoke well and answered questions from the floor.

Several years ago, at our annual banquet, held at Har Zion, he again addressed us and recalled speaking to us at our First Federal bank building meeting, but to a much smaller crowd.

His application for membership was accepted on November 13, 1980. In the 1990's, he marched with our group during the Israel Independence Day parade.

Mosque at Ground Zero

Former speaker of the House **Newt Gingrich** recent speech on the proposed "**Cordoba House**" Mosque at ground zero -

There should be no mosque near Ground Zero in New York so long as there are no churches or synagogues in Saudi Arabia. The time for double standards that allow Islamists to behave aggressively towards us while they demand our weakness and submission is over.

The proposed "Cordoba House" overlooking the World Trade Center site - where a group of jihadists killed over 3,000 Americans and destroyed one of our most famous landmarks - is a test of the timidity, passivity and historic ignorance of American elites.

For example, most of them don't understand that "Cordoba House" is a deliberately insulting term. Today, some of the mosque's backers insist this term is being used to "symbolize interfaith cooperation" when, in fact, every Islamist in the world recognized Cordoba as a symbol of Islamic conquest. It is a sign of their contempt for Americans and their confidence in our historic ignorance that they would deliberately insult us this way.

Those Islamists and their apologists who argue for "religious tolerance" are arrogantly dishonest. They ignore the fact that more than 100 mosques already exist in New York City. Meanwhile, there are NO churches or synagogues in all of Saudi Arabia. In fact no Christian or Jew can even enter Mecca.

And they lecture us about tolerance.

If the people behind the Cordoba House were serious about religious toleration, they would be imploring the Saudi's, as fellow Muslims, to immediately open up Mecca to all and immediately announce their intention to allow non-Muslim houses of worship in the Kingdom.

They should be asked by the news media if they would be willing to lead such a campaign.

We have not been able to rebuild the World Trade Center in nine years. Now we are being told a 13 story, \$100 million mega-mosque will be built within a year overlooking the site of the most devastating surprise attack in American history.

Finally, where is the money coming from? The people behind the Cordoba House refuse to reveal all their funding sources.

America is experiencing an Islamist cultural-political offensive designed to undermine and destroy our civilization. Sadly, too many of our elites are the willing apologists for those who would destroy them if they could.

No mosque. No self deception. No surrender. The time to take a stand is now - at this site - on this issue.




